

#### **Budget:**

Through a long process we have narrowed down our Designated Accounts to one page. One of our goals is to present a simplified presentation of the budget. Our designated accounts presently creates an impression that we have a great deal of money. The gifts and pledges to the operating budget is crucial to keep us going. Funds from the Designated Accounts presently do not address our everyday expenses.

**Bill Scott:** 2020 changes that are being made will make the budget clearer. We need to bring in more money to the operating expenses to keep us going as we cannot use the revenue from the DG funds. Op Funds are used for Salaries, electric, garbage, insurance etc. 2020 was exceptional, people came through and continued to make contributions. We also had a gift from Margo Meyer, the PP loan (which added \$50,000.) Without those gifts we would have been 30,000 in the hole. You will be in good hands with Linda.

#### Linda Banta:

Thanks to Kathy Hart, Bill Scott, NormaLee Andres for leaving the budget in as good hands as has been. If you look at the long list of operating expenses and compare it with the income, it appears that we are running about \$2900 shortfall a month. The cost of presbytery comes on top of the pledges. She wants to give monthly updates and asks for the congregation's prayers. Thanks for the opportunity to serve.

Our Rainbow school will hopefully be open in April. We don't know.

**Susan Holly** reminded us that contribution is about time, treasure and talents. It is all that we give.

#### Pastor's report:

Our Church staff is terrific –We are experiencing the loss of Sunny Farley and Kathy Mooney. We can't underestimate the ways they have impacted our community and church.

#### Terms of Call:

Elizabeth Kirkpatrick-Vrenios presented the terms of call for this year:

Pastor Matt's annual Salary of \$86,400 including cash and housing

Reimbursable Expenses: \$3,000

Continuing Education: Rationale for the \$0 amount in terms of call: Upon approval by MPC Session monies from 2021 (\$2,000) were combined with monies from 2020 (\$2,000) to pay classes for Doctor of Ministry classes in 2020.

Paid Vacation one month per year

Continuing Education Study Leave of Two Weeks per year which is cumulative.

Elizabeth recommended carrying over \$500 not used last year for reimbursable expenses. It was moved and seconded that we maintain the same terms of call for next year, reimbursing \$500 for unused expenses.

**Kathleen Alexander:** As for me, my strongest desire is that we are not just seen as a nice friendly church, but that because of the way we live out the gospel of Jesus Christ, we will attract the attention of a younger generation that is drawn to MPC because we reflect the relevance of the gospel as it speaks to the needs of our time. I pray that young people will fill in the ranks and energize us with a forward-thinking vision, and that we become a force to transform our locale, as a body of believers living out in concrete ways God's compassion for others – not in talk but in deed.

Darlene Clay moved to adjourn the meeting with Linda Banta seconding. The meeting adjourned at 1:43 pm with a prayer from Reverend Matt Davis.

Through three congregational conversations, MPC leadership was able to hear the needs in the community and the yearnings of our heart. As we move into 2022, the Session hopes to use the insights and reflections of these conversations to focus and inspire. Personally, I hope that God is using this process to discern partners in ministry in the broader community. These might be individuals who have simply never been invited to be with us in worship or to sing in the choir. There might be still others in the community who would love to serve as a volunteer in our ministries of hospitality like on Tuesday and Thursday. Other partners might be institutional like a renewed commitment to host the Mendocino Music Festival lifting up the power and gift of music. There might other new institutional partners who could help us reflect our commitments to the wider community like the Mendocino Film Festival. For example, MPC might host events on our campus for the Film Festival or even sponsor one of the documentary films. #### PERSONNEL COMMITTEE WORK OF 2021

After a few months of break and transition of committee membership, the Personnel Committee met bimonthly starting in July of 2021. Committee members recommended guidelines for COVID safety, including guidelines regarding vaccinations, masking and safety protocols for staff. We supported Rainbow School in developing practices for the safety of students and staff.

The committee appreciates the support provided by staff and volunteers during these difficult times that call for change and new ways of serving members and community. These changes resulted in reduced staffing of one part-time counselor early in 2021 and one part-time maintenance position.

The Personnel Committee developed plans for security clearance for staff and key volunteers, and this should be implemented early in 2022.

We are grateful for the loving care, flexibility and professionalism demonstrated by staff as we navigate challenges of pandemic and alternative ways of working and gathering.

#### **WORSHIP COMMITTEE ANNUAL REPORT**

The Worship Committee was led this year by Elder Robert Scott and supported by Elder Sally Swann. Also serving were Karen Moreland, Jim Hunter, Matt Leach, Elder Lois Leister and Office Manager Tammy Fites. Rev. Matthew Davis and Music Director Marie-Claire Dizin also were staff liaisons to the Worship Committee.

Typically, the Worship Committee met once a month.

The Worship Committee is responsible for the regular maintenance of worship at MPC. In 2021, the Mendocino community was invited to attend in person worship in the sanctuary, on the patio as well as online experiences. Because of the COVID pandemic, there were periods of time when the Session discerned for health reasons that it best to only hold worship online. We pray that we are moving into a less dangerous season of COVID. We lift up healing prayers for all those impacted and we are committed to ensure that our worship experience is as safe as possible.

#### Highlights:

Regular worship never felt as extraordinary as this year. Thankful to the ushers and greeters who made worship participants feel so welcome.

We are thankful for those days when we could also offer coffee hour on the patio following worship.

The online worship experience would not have been possible without the time, talent and creativity of Barbara Foote and Office Manager Tammy Fites. Every Sunday, Barbara and Tammy work together to film, edit and upload the MPC worship experience. Incredibly thankful for having this online presence through their hard work.

The Easter Sunrise service continues to be a great outreach to the larger community as well as a joy for members and friends of the church. At least 50 people attended Easter Sunrise service down at the Big River Beach (just east of bridge) affirmed through a beautiful fire along with communion.

For much of the Fall 2021, the Worship Committee encouraged weekly communion through intention. This was meaningful to so many in the faith community.

Worship was affirmed by study of the Bible through Woman's Bible Study (led by Pat Westfall) and Men's Bible Study (led by Don Bettencourt).

Rev. Matthew Davis experimented with various times of study including a month-long study of racism in conversation with our faith journeys.

As always, it is the prayerfulness of MPC that taps into the Holy Spirit affirming the larger community. We give thanks for the humble yet joyful spirit permeating our worship experience.

We are also richly blessed by the ongoing dedication of our Finance secretary, Michael Moreland who faithfully coordinates the giving contributions for our church.




